I. Introduction

Centre for Development Activities (CDAC) is a registered state level voluntary organisation working for the welfare and development of women & children, care & protection of children, care of senior citizens, promotion of mental health etc. It was established by a group of young energetic & enthusiatic youths, women and social workers of Wangjing in 1989 with the objectives of eradication of illiteracy in rural areas, particularly among women, to promote rural health & sanitation, popularisation of science in rural areas, introduction of modern implements in agriculture, conservation of environment, promotion of peace & communal harmony etc. In the year 2015 we became a state level organisation and has members from 10 (ten) districts of the state belonging to various walk of life which enabled us to serve the people of the state better. We have also opened our first district office at Moreh Town of Tengnoupal District in March, 2015.

II. Legal Status

We were established as a non-profit, non-political, non-religious and non-sectarian social welfare voluntary organisation on 28th September,1989 and has been granted registration under the (i) Manipur Societies Registration Act, 1989 (Act No.1 of 1990), (ii) Foreign Contribution (Regulation) Act, 1976, (iii) Income Tax Act, 1961 (U/s 12 AA), (iv) Rights of Persons with Disabilities Act, 2016, (v) Immoral Traffic (Prevention) Act, 1956, (vi) Juvenile Justice (Care and Protection of Children) Amendment Act, 2021 and (vii) Mental Healthcare Act, 2017.

III. Vision & Mission

Vision: We visualize a society where peace, justice and equality prevails and wherein all citizens irrespective of castes, creed, sex, culture, tradition, languages, religions live in peace & harmony. It also visualizes a society where the poor, the marginalised and the weaker sections have an equal opportunity of their involvement in the welfare and development process which is value based, sustainable, environment friendly and also have an opportunity to develop their fullest potential.

Mission: Rendering welfare and development services to all community members who need such a service with their active participation to attain a well being way of life in the society and peaceful co-existence.

- h) Welfare and rehabilitation of physically, mentally and audio-visually challenged persons.
- Senior Citizen's welfare programmes.

Activities undertaken during the year 2023-2024

1. Shakti Sadan - Integrated Relief and Rehabilitation Home

CDAC Manipur has been implementing the Ujjawala project since July 2008 at Moreh (border town-neigbouring with Myanmar) in Tengnoupal District under the Ministry of Women & Child Development, Govt. of India, New Delhi under its scheme UJJAWALA - A Comprehensive Scheme for Prevention of Trafficking and Rescue, Rehabilitation and Reintegration of victims of Trafficking for Commercial Sexual Exploitation. The Ministry of Women and Child Development was implementing the schemes of Swadhar Greh for Women in difficult circumstances and Ujjawala for Prevention of Trafficking. Both the

schemes were aimed at creating a safe and enabling environment for the women in distress including trafficked women and thereby give them the strength to overcome their difficult circumstances and make a fresh start. For administrative purposes, Swadhar and Ujjawala Scheme have been merged and these will be known as 'Shakti Sadan' - Integrated Relief and Rehabilitation Home.

At **Epamlamdam Shakti Sadan** - Integrated Relief and Rehabilitation Home, we are providing rehabilitation,reintegration and repatriation to country of origin to 50 survivors of human trafficking and women in distress who were rescued/referred by the Police,CVGs,CWCs,Childlines and other civil society organisations. At Shakti Sadan these women/girls were rehabilitated through counselling and vocational trainings and re-integrated to their family by Social Workers,Clinical Psychologist and vocational trainers General and mental health care are also done by our Doctors /Psychiatrists. We also assisted them in legal matters and provided finanacial assistance for economic empowerment. Formal and non-formal education are also given to young women and girls.

2. CDAC's Senior Citizen's Home for Women

Senior Citizen's Home for women at Moreh, Tengnoupal District has been running under *National Action Plans for Senior Citizens (NAPSrC)* of the Ministry Social Justice & Empowerment, Govt. of India, New Delhi since 1/4/2018. The home is providing shelter to 25 abandoned ,uncared for and homeless female senior citizens. At the home we takes care of both physical and mental health, hygiene of senior citizens by our counsellor/social workers, doctor and nursing staffs. Physical exercise and yoga are also arranged to keep inmates fit and relax.

Recreational facilities like library, messeges by pastors or religious leaders, health talks, traditional story telling on meitei puya, bashak, moirang/khongjom parva, khunung eshei, watching of TV, screening of video films etc. are also arranged. They are also taking out for site seeing, excursion to different historical places, temples and religious

congragations are also arranged from time to time. Vocational trainings on making of soft toy, agarbati, papad, paper bag etc. are also imparted for using their leizure time in productive works. These products are highly demand for local consumption. We also observed International Day of Older Persons every year at the home. Our staffs have also attended training courses of various level conducted by RRTC and NISD, New Delhi from time to time. Our home is inspected and monitored by DSWO, Tengnoupal, RRTC and Ministry officials every now & then.

3. Centre for Mental Health & Rehabilitation (Half-Way Home)

Half-Way Home for psycho-social rehabilitation of treated & controlled mentally ill persons has been running under Deendayal Disabilities Rehabilitation Scheme (DDRS) of the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment, Govt. of India, New Delhi since February, 2015. Our centre is granted registration under section 49 of the Rights of Persons with Disabilities Act, 2016 and Mental Health Care Act, 2017. The centre has

,soft toy making etc. and also provides psycho-social and economic rehabilitation to the treated & controlled mentally ill persons.sInmates of the centre are mainly recommended by state social welfare department, psychiatrist, medical officers, elected members of local self government, local clubs, police etc. Inmates of the centre are given psycho-social counselling and rehabilitation service by Clinical Psychologist, Social Workers and Occupational Therapist, mental health and general health care are taken care by Psychiatrist, Doctors and nursing staffs as part of rehabilitation.

4. Epamlamdam Open Shelter for Girls

Epamlamdam Open Shelter for Girls at Moreh, Tengnoupal District was started in the year 2015 with the financial support from the Ministry of Women & Child Development, Govt. of India, New Delhi under the Mission Vatsalya (erstwhile Integrated Child Protection Scheme) through the Department of Social Welfare, Govt. of Manipur. Now it has been shifted at Wangjing, Thoubal District, Manipur due to communal conflict. The objective of the shelter is to provide an opportunity for the increasing number of vulnerable children in urban areas to be protected from abuse and neglect on the street and provide

them access to alternatives. Our shelter caters its services to 25 girls who are in need of care and protection particularly beggars, street and working children, rag pickers, small vendors, street performers, orphaned, deserted, trafficked and runaway children, children of migrant population and any other vulnerable group of children.

5. Holy Children Home for Boys Holy Children Home for Boys, Moreh,

Tengnoupal District was started during

2020-2021 with the aim of providing long term shelter, education and care to children in need of care and protection. The home is supported by the Ministry of Women & Child Development, Govt. of India, New Delhi under the *Mission Vatsalya (erstwhile Integrated Child Protection Scheme)* through the Department of Social Welfare, Govt. of Manipur. The home provides shelter, care, foods education to 50 boys/children who are in need of care and protection. Above

this services, children are encourage to take up vocational training for employment and self-employment, sports activies, exposure visits to government offices, colleges, ITIs etc. for all round development.

6. Day Care Centre for Persons with Mental Illness


Day care centre for persons with mental illnes at Wangjing, Thoubal district was started in August, 2021 under PPP mode of National Mental Health Program, State Health Society, Manipur. The

objective of this day care centre is to provide a facilitating mechanism for rehabilitation of persons with severe mental illness after their discharge from hospital. Presently the centre provides the following facilities: i) Psychiatrist and Doctor consultation,

- ii) Psycho-social Counselling, iii) Nursing Care,
- iv) Vocational Counselling and Training, v) Yoga
- vi) Recreational & entertaintment services e.g. TV, badminton, carom, Chess, Ludo etc., ix)Transport,
- x) Residential facility, xi) Free psychotropic medicines (to be provided through DMHP,Thoubal)




7. Catract Detection Camp for Senior Ctizens

8. Vocational Training-cum-Production Centre

i) Handloom Unit: We started the handloom weaving unit with the aims of socio-economic upliftment of rural poor women through handloom production thereby increasing the handloom products. About 50 rural poor women/girl are given basic and advanced skill training on handloom weaving (fly shuttle looms) and designing for three months at the Centre. We also trained them on marketing techniques and financial management. The trained women are provided raw materials and produces variety of handloom products ranging from phanek,inaphee,bedsheet,chingphee,towel etc.at the Centre. Raw materials are also provided to those trained women

who wish to work from their home. All the finished products are collected at the centre and marketted.

conducting 12 months Embroidery, Tailoring & Cutting training for Other Backward Classes (OBCs) women, girls and youths since last many years. The main objective of the programme is to impart skill development training to girls, women and youths belonging to other backward classes (OBCs) so that they can take up the trade for self-employment after the training. During this year the programme benefitted about 50 girls, women and youths from Salungpham areas of Thoubal District. At the Centre, trainees were
